4. First Aid Measures

Eye Contact: Flush eyes immediately with water for at least 15 minutes. Get medical attention if irritation develops.

Skin Contact: Flush skin immediately with water for at least 15minutes. Get medical attention.

Inhalation: Remove patient to fresh air. If not breathing, give artificial respiration. Get medical attention.

Ingestion: Do not induce vomiting. Get medical attention. Do not give anything by mouth to an unconscious person. If conscious, drink a large quantity of milk or water.

6. Accidental Release Measures: Ensure suitable personal protection during removal of spillages. Spills should be contained and may be cautiously neutralized with sodium bicarbonate, or absorbed on appropriate material and placed in a container for disposal. Flush spill site with large quantities of water to a sanitary sewer. Washings should be prevented from entering surface water/storm drains. Local regulations should be observed.
